

### Independent reviewer's report

REVIEW REPORT TO THE COUNCIL MEMBERS OF THE ASSOCIATION FOR THE ADVANCEMENT OF FEMINISM (the "Organisation") OF LOTTERY EVENT ("THE EVENT") LOTTERY LICENCE NO.004826

In accordance with the engagement letter dated 21 June 2022, we have performed the agreed upon procedures in reviewing the attached income and expenditure account ("IEA") of the Organisation's lottery event, the draw of which was held on 18 April 2022. Our engagement was conducted in accordance with Practice Note 852 "Review of lottery accounts" issued by the Hong Kong Institute of Certified Public Accountants. This report is made solely in relation to the above lottery event and does not relate to any other part of the operations of the Organisation. The agreed upon procedures that we have carried out did not constitute an audit of the attached IEA of the Organisation's lottery event, and accordingly they cannot be relied upon to provide the same level of assurance as an audit.

no matter has come to our attention which indicates that the attached IEA of the Organisation's lottery event does not accurately reflect all the monies collected or received from the sale of lottery tickets by the Organisation during the lottery event and all the disbursements made from the monies so collected or received.
