REVIEW REPORT
TO THE BOARD OF DIRECTORS OF
HONG KONG SHENG KUNG HUI WELFARE COUNCIL LIMITED (“the Council”)

In accordance with the engagement letter dated 17 November, 2023, we have performed the agreed upon procedures in reviewing the attached income and expenditure account (“IEA”) of the Council’s lottery event for sale of lottery tickets, the draw of which was held on 8 December, 2023. Our engagement was conducted in accordance with Practice Note 852 “Review of lottery accounts” issued by the Hong Kong Institute of Certified Public Accountants. This report is made solely in relation to the above lottery event and does not relate to any other part of the operations of the Council. The agreed upon procedures that we have carried out did not constitute an audit of the attached IEA of the Council’s lottery event, and accordingly they cannot be relied upon to provide the same level of assurance as an audit.

Use of this report

This report is intended solely for the purpose of satisfying Condition 6 of Lottery Licence No. 004875 issued on 1 August, 2023 by the Office of Licensing Authority of Home Affairs Department of the Government of the Hong Kong Special Administrative Region to the Council, and is not intended to be, and should not be, used for any other purpose.

Review conclusion

On the basis of the results of the agreed upon procedures performed by us:


- a. in our opinion the attached IEA of the Council’s lottery event is properly prepared from the books and records of the Council made available to us; and
- b. no matter has come to our attention which indicates that the attached IEA of the Council’s lottery event does not accurately reflect all the monies collected or received from the sale of lottery tickets by the Council during the lottery event and all the disbursements made from the monies so collected or received.

NOTES TO THE LOTTERY ACCOUNTS “SALE OF LOTTERY TICKETS”
FOR THE PERIOD FROM 15 OCTOBER, 2023
TO 8 DECEMBER, 2023

1. General

In accordance with Section 22(1)(a)(i) of the Gambling Ordinance (Cap.148), Hong Kong Sheng Kung Hui Welfare Council Limited has obtained a Lottery Licence No. 004875 on 1 August, 2023 from the public officer appointed by the Secretary for Home and Youth Affairs in respect of the Council’s sale of lottery tickets held during the period from 15 October, 2023 to 8 December, 2023. The draw of the lottery event was held on 8 December, 2023.

2. Basis of preparation

The income and expenditure account has been prepared on the cash basis. On this basis, income is recognised when received and expenditures are recognised when paid.

3. Purpose of fund raising

The net proceeds from the lottery event held for the period is for raise fund, use for the development of the Welfare Council’s various social services, including those for the childcare, youth, families, elderly, rehabilitation, counselling, ethnic minorities and medical services for the community, etc.
