In accordance with the engagement letter dated 5th May, 2025, we have performed the agreed upon procedures in reviewing the Statement of Income and Expenditure account on page 3, which sets out all monies collected or received from the sale of lottery tickets and all disbursements made from the monies so collected or received in respect of the lottery event held by Bosco Charity Association Limited (the "Association"), of which the draw was held on 10th July, 2025. We have conducted our review in accordance with Practice Note 852 "Review of lottery accounts" issued by the Hong Kong Institute of Certified Public Accountants. 
