Notes :

1. The licensee must comply with all laws in the Hong Kong Special Administrative Region (“HKSAR”), including but without limitation to the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (“National Security Law”) and other relevant laws of the HKSAR in relation to the safeguarding of national security (“relevant laws”). In particular, Article 3 of the National Security Law provides that it is the duty of the HKSAR under the Constitution of the People’s Republic of China to safeguard national security and the HKSAR shall perform the duty accordingly, and that the executive authorities, legislature and judiciary of the HKSAR shall effectively prevent, suppress and impose punishment for any act or activity endangering national security in accordance with the National Security Law and other relevant laws. Article 6(2) of National Security Law provides that any institution, organisation or individual in the HKSAR shall abide by the National Security Law and the laws of the HKSAR in relation to the safeguarding of national security, and shall not engage in any act or activity which endangers national security. It is therefore the duty of the licensee to ensure that the conduct of the games of amusement with prizes will not involve any act or activity which would or is likely to constitute or cause the occurrence of any offence endangering national security or any act or activity which would otherwise be contrary to the interests of national security, and that no such act or activity will be undertaken by the licensee and/or its employees, agents, sponsors, promoters and contractors and any other person(s) who will be involved in the organisation

or operation of the games of amusement with prizes. In accordance with section 22(4) of the Gambling Ordinance, the public officer appointed by the Secretary for Home and Youth Affairs (“the public officer”) may cancel the licence at any time if a condition of the licence is contravened or if he/she considers that the public interest so requires. National security interest is an important aspect of public interest to be considered by the public officer in such regard. Licensees failing to observe the licence condition(s) and/or their obligations in relation to the safeguarding of national security are liable to have their licence cancelled.

2. The public officer is entitled to reject the renewal application if, amongst others, the public officer has reasonable ground to believe that: -
 - (a) the applicant or any of its employees, agents, sponsors, promoters, contractors and any other person(s) who will be involved in the organisation or operation of the games of amusement with prizes (including but without limitation to the person(s) involved as stated by the applicant in the application form) has engaged in or otherwise been involved in, or will engage in or otherwise be involved in, any act or activity which would or is likely to constitute or cause the occurrence of any offence endangering national security or any act or activity which may otherwise be contrary to the interests of national security.
 - (b) the conduct of the games of amusement with prizes will involve any act or activity which would or is likely to constitute or cause the occurrence of any offence endangering national security or any act or activity which may otherwise be contrary to the interests of national security.
3. The licensee can submit the application form in person or by mail. You can also submit the application via the electronic submission channel at (<https://eform.cefs.gov.hk/form/had062/en/>). For forms submitted via electronic submission channel, the licensee has to submit the required supporting documents (*if applicable*) with the transaction reference number quoted to the OLA (by hand or by mail), *within 7 working days* after making the electronic submission. 4. Upon renewal of the licence, a demand note will be issued to the licensee for payment of the licence fee. Please refer to the back of the demand note for the payment methods. Please note that we **do not handle cash/cheque transactions. Do not send cash/cheque by mail.**
5. The personal data provided above will be used for facilitating assessment of your application for renewal of the licence; enforcement of the laws, regulations or conditions in respect of the licence; and communication between Government and yourself on relevant licensing matters.
6. This form must be completed in full. If you do not provide sufficient information, we may not be able to process your application.
7. The public officer may, if he/she considers necessary, require the applicant to provide further information in support of the licence renewal application. All information provided in connection with the licence renewal application may be referred to other Government bureaux/departments or organisations for purposes in connection with the processing of the licence renewal application.
