**Latest Directions by the Secretary for Food and Health  
published on 8 September 2020  
(Government continues to relax social distancing measures under  
Prevention and Control of Disease Ordinance in a gradual and orderly manner)**

Taking into account the fact that local epidemic wave has continued to subside and the situation is stabilising gradually, as well as the need for the society as a whole to resume social and economic activities, the Government has decided to continue to relax social distancing measures in a gradual and orderly manner.

2. The Secretary for Food and Health published the latest directions on 8 September 2020 under the Prevention and Control of Disease (Requirements and Directions)(Business and Premises) Regulation (Cap. 599F). Among the directions given, amusement game centres (i.e. those under the definition stipulated in the Amusement Game Centres Ordinance (Cap. 435)) may be open subject to the relevant requirements and restrictions.

3. The latest directions will be effective from 11 September 2020 to 17 September 2020, for a period of seven days. For details of the relaxation of certain social distancing measures under Prevention and Control of Disease Ordinance and the summary of the latest directions, please refer to [the Government press release](#)<sup>1</sup> published on 8 September 2020 and [the Government Notice published in Government Gazette](#)<sup>2</sup>.

4. Since the epidemic situation could still fluctuate, special arrangements may have to be re-introduced at short notice. Please continue to pay attention to further updates available on the website of the Centre for Health Protection (CHP) of the Department of Health. Thank you for your support.

**食物及衛生局局長於2020年9月8日發出的最新指示  
(政府繼續逐步有序放寬《預防及控制疾病條例》下的社交距離措施)**

考慮到本港疫情持續放緩並漸趨穩定，以及社會整體對進一步恢復社交及經濟活動的需要，政府決定繼續逐步有序放寬社交距離措施。

2. 食物及衛生局局長按《預防及控制疾病(規定及指示)(業務及處所)規例》(第599F章)於2020年9月8日發出了最新指示。當中，遊戲機中心(即在《遊戲機中心條例》(第435章)下定義的遊戲機中心)在符合相關規定及限制下可予開放。

3. 最新指示於2020年9月11日至2020年9月17日期間生效，有效期為七天。有關政府是次放寬部分《預防及控制疾病條例》下的社交距離措施的詳情及指示摘要，請參閱政府2020年9月8日發出的[新聞公報](#)<sup>1</sup>，以及[在憲報刊登的政府公告](#)<sup>2</sup>。
