Licence Condition Nos. 3, 4 and 8 of Amusement Game Centre Licence relating to (a) Transfer of Licence

(b) Appointment of Agent

(c) Application for a change of layout plan

This letter serves to remind all licensees of Amusement Game Centre to seek the prior approval of the Office of the Licensing Authority (OLA) for the captioned matters by submitting the required application forms in order to comply with the licence conditions below –

- (a) under **Condition No. 3** of the Amusement Game Centre (AGC) Licence, the licensee shall not transfer his licence to another person except as provided in section 6 of the AGC Ordinance. Licence holders are reminded to submit application for transfer of licence and obtain our approval **before** the change of licence holders or the change of holding body corporate/partnerships. All such applications for changes should be made by completing Forms T, T-3, Ta and Tb.
- (b) under **Condition No. 4** of the AGC Licence, it is the licensee's responsibility to report to OLA, within 7 days from the date of appointment, any person newly appointed as an agent to manage the centre, by filling in the written delegation Form T-5 and return it to OLA either by hand or by post to the following address:

And, a copy of the completed written delegation Form T-5 shall also be kept in the premises concerned for inspection.

- (c) under **Condition No. 8** of the AGC Licence, the AGC premises shall be operated in strict accordance with the layout plan approved by the public officer appointed by the Secretary for Home Affairs. Application for a change of the layout plan is not required provided :
 - (i) the size of a new machine does not exceed that of the one to be replaced in situ;
 - (ii) there is no change in the total number of machines/devices in the premises;
 - (iii) there is no structural alterations to the premises;
 - (iv) there is no alterations to means of escape; and
 - (v) no machines requiring endorsement of Electrical and Mechanical Services Department are involved.

Licence holders are therefore reminded to submit application (with completed Form T-2 and revised layout plan) to OLA for approval before a change of the approved layout.
