## Application of Code of Practice for Fire Safety in Buildings 2011 to Karaoke Establishments

I am writing to inform you that the Code of Practice for Fire Safety in Buildings 2011 (FS Code) will come into operation on 1 April 2012. In this connection, you may wish to note that for karaoke establishment permit/licence applications **received on or after 1 April 2012**, the premises under application together with the affected exit routes and fire resisting constructions should comply with the requirements of the FS Code. For applications for alteration of licensed karaoke establishments received on or after 1 April 2012, only the proposed altered parts of the premises and the affected exit routes and fire resisting constructions should comply with the requirements of the FS Code.
