The Financial Secretary announced on 15 August 2019 a package of measures to support enterprises, safeguard jobs and relieve people's financial burden, including waiving licence fees for hotels and guesthouses for 12 months. Details of the arrangement are set out as below –

- (a) 12-month licence fees payable in respect of hotel and guesthouse licences issued or renewed during the concession period (i.e. 1 October 2019 to 30 September 2020) will be waived;
- (b) For those licence holders with their licences issued or renewed with the prescribed fees settled before the concession period
 - if the licence expires after the concession period, the Office of the Licensing Authority (OLA) under the Home Affairs Department will arrange refund to the licence holder. Upon receipt of the refund application, the OLA will refund the licence fees, on a pro-rata basis, to the licence holder.
 - if the licence expires within the concession period, no refund will be arranged for the licence holder. Instead, the holders of these licences will enjoy the waiver of licence fees, on a pro-rata basis, upon their submission of renewal application for licence in the course of the concession period.

Since your licence will expire within the concession period, you will enjoy the waiver of 12-month licence fees if your licence is renewed within the concession period.
