## Anti-epidemic Fund "Licensed Guesthouses Subsidy Scheme"

The Government established the Anti-epidemic Fund to launch a series of schemes to combat the novel coronavirus virus and to provide timely assistance or relief to enterprises and members of the public. The "Licensed Guesthouses Subsidy Scheme" (the Scheme) under the fund provides subsidies to eligible guesthouse. For each guesthouse with one to five licensed guestrooms, a one-off subsidy of \$50,000 will be provided. For those with six or more licensed guestrooms, the amount of the one-off subsidy is \$80,000.

2. According to records, your guesthouse is eligible to join the Scheme by registration. For details, please refer to the attached Licensed Guesthouse Subsidy Scheme – Guide to Registration. The major points are set out below.

#### **Registration period**

3. Guesthouses must submit the registration form with the required document to the Office of the Licensing Authority (OLA) under the Home Affairs Department between 21 February 2020 and 20 March 2020 (both dates inclusive). <u>Late submission of registration form will not be accepted</u>. For registrations submitted by post, the postmark will be taken as the date of submission.

#### **Registration procedure**

- 4. Guesthouse may complete the "Licensed Guesthouses Subsidy Scheme" Registration Form (attached in this letter) and submit together with documentary proof of bank account (e.g. a copy of first page of bank book or bank statement, which should clearly shows the name of bank, name of bank account and account number) to the OLA by post or in person. Registration form is also available for download at OLA website (www.hadla.gov.hk) or collection from its office.
- 5. If a guesthouse submits the registration form by fax or email (please see paragraph 8 for contact details), it has to submit the original registration form afterwards. The OLA will verify the original registration form before arranging payment.
- 6. The name of the guesthouse licence holder's bank account must tally with that in the guesthouse licence, otherwise the OLA may require supplementary information from the guesthouse licence holder for verification. If the guesthouse licence holder is unable to provide the required information, it will not be granted the subsidy.

## Disbursement of subsidy

7. The OLA will arrange to disburse the subsidy through direct transfer to the designated bank account of eligible guesthouse licence holders, and to inform them of such through letters/emails (if available).

# **Licensed Guesthouses Subsidy Scheme Guide to Registration**

(Registration period: 21 February 2020 to 20 March 2020)

## **Introduction**

The Government established the Anti-epidemic Fund, and the Licensed Guesthouses Subsidy Scheme under the Fund provides subsidies to guesthouses. Each eligible guesthouse:

- (a) with 1 to 5 licensed guestrooms: may receive a one-off subsidy of \$50,000;
- (b) with 6 or more licensed guestrooms: may receive a one-off subsidy of \$80,000.

## **Eligibility**

- 2. Guesthouses must fulfill the following two criteria:
  - (a) it held a valid guesthouse licence issued under the Hotel and Guesthouse Accommodation Ordinance (i.e. any of the three types of guesthouse licences, namely "guesthouse (general)", "guesthouse (holiday flat)" and "guesthouse (holiday camp)") as at 21 February 2020; and
  - (b) it continues to hold a valid guesthouse licence when the subsidy is disbursed to it by the Government.

#### **Registration period and procedures**

#### Registration period

3. Guesthouse must submit the registration form with the required document to the Office of the Licensing Authority (OLA) under the Home Affairs Department between 21 February 2020 and 20 March 2020 (both dates inclusive). Late submission of registration forms will not be accepted. For registrations submitted by post, the postmark date will be taken as the date of submission.

## Registration procedure

- 4. Guesthouse may download the registration form on the OLA's website (www.hadla.gov.hk) or obtain it from its office. Completed registration forms should be submitted together with the documentary proof of bank account (e.g. a copy of first page of the bank book or bank statement, which should clearly shows the name of bank, name of bank account holder and account number) to the OLA by post or in person.
- 5. If a guesthouse submits the registration form by fax or email (please see paragraph 8 for contact details), it has to submit the original registration form afterwards. The OLA will verify the original registration form before arranging payment.
- 6. The name of the guesthouse licence holder's bank account must tally with that in the guesthouse licence, otherwise the OLA may require supplementary information from the guesthouse licence holder for verification. If the guesthouse licence holder is unable to provide the required information, it will not be granted the subsidy.

#### **Disbursement of subsidy**

7. The OLA will arrange to disburse the subsidy through direct transfer to the designated bank account of eligible guesthouse licence holders, and to inform them of such through letters/emails (if available).
