Dear Sir/Madam,

Hotel and Guesthouse Accommodation Ordinance, Cap. 349 **Combating Unlicensed Operation**

In view of the recent concern about unlicensed hotels/guesthouses, I am writing to remind you of the relevant provisions under the Hotel and Guesthouse Accommodation Ordinance (Cap. 349) (the Ordinance) against unlicensed operation.

According to Section 2 of the Ordinance, "hotel" and "guesthouse" mean any premises whose occupier, proprietor or tenant holds out that, to the extent of his available accommodation, he will provide sleeping accommodation for any person presenting himself who appears able and willing to pay a reasonable sum for the services and facilities provided and is in a fit state to be received. Under Section 5 of the Ordinance, any person who on any occasion operates, keeps, manages or otherwise has control of a hotel/guesthouse without a valid licence commits an offence and is liable on conviction to a fine of \$ 200,000 and to imprisonment for 2 years and to a fine of \$20,000 for each day during which the offence continues. Similarly, operating, keeping, managing or controlling a hotel/guesthouse in any premises other than the premises indicated in a licence is an offence under Section 21(3)(b) of the The offender is liable on conviction to a fine of \$ 100,000 and to imprisonment for 2 years and to a fine of \$10,000 for each day during which the offence continues.

In addition, the Hotel and Guesthouse Accommodation Authority (the Authority) will consider invoking Section 10 of the Ordinance to cancel/refuse to renew all licences of a licence holder if the licence holder is convicted of operating an unlicensed guesthouse under Section 5 or 21(3)(b) of the You may wish to note that the Authority has cancelled/refused to renew three licences accordingly. A copy of the "Enforcement News" posted in the website www.hadla.gov.hk is attached for your attention.

The Office of the Licensing Authority (OLA) will continue its vigorous action to combat illegal operation. In this connection, OLA will strengthen enforcement action and mount more blitz operations against suspected licensed premises.

Enforcement News Office of the Licensing Authority

- 1. The Office of the Licensing Authority (OLA) is responsible for administering and taking enforcement actions under the Hotel and Guesthouse Accommodation Ordinance, Cap. (the Ordinance).
- 2. Under Section 5(1) of the Ordinance, any person who operates, keeps, manages or otherwise has control of a hotel/guesthouse without a valid licence would commit an offence, and is liable on conviction to a fine of \$200,000 and to imprisonment for 2 years and to a fine of \$20,000 for each day during which the offence continues.
- 3. Moreover, under Section 21(3) of the Ordinance, any hotel/guesthouse licence holder who operates, keeps, manages or otherwise has control of a hotel/guesthouse in any premises other than the premises indicated in the licence so issued would commit an offence, and is liable on conviction to a fine of \$100,000 and to imprisonment for 2 years and to a fine of \$10,000 for each day during which the offence continues.
- 4. The following are convictions for contravention of Sections 5(1)/21(3) of the Ordinance and sentenced for imprisonment:

5. The following guesthouse licences have been cancelled/refused to renewed under Section 10 of the Ordinance after the licensees had been convicted against contravention of Sections 5(1)/21(3) of the Ordinance:

6. The OLA will continue to take vigorous action to combat unlicensed operation to ensure the safety of lodgers and the public.
