- (a) 12-month fees payable in respect of karaoke establishment licences/permits issued or renewed during the concession period (i.e. 1 October 2019 to 30 September 2020) will be waived:
- (b) For those licence/permit holders with their licences/permits issued or renewed with the prescribed fees settled before the concession period
 - if the licence/permit expires after the concession period, the Office of the Licensing Authority (OLA) under the Home Affairs Department will arrange refund to the licence/permit holder.
