# Key Points of The Licensing Regime



No-use Restriction Requirement

"Fit and Proper" Requirement

# No-use Restriction Requirement



**!**  
The lease of the concerned premises has no restrictive provisions from being used as a hotel / guesthouse.

**!**  
The licence applicant should provide the solicitor's letter as proof.



# Suitability Requirement

LICENSEE  
MUST

- Operate, keep, manage the hotel/guesthouse under the continuous and personal supervision
- Ensure the premises in a proper condition
- Satisfy the building and fire safety requirements



# The Licensee must fulfill the "Fit and Proper" Requirement

The Authority will consider whether the applicant or related person is a fit and proper person to operate, keep, and manage a hotel or guesthouse.



Have not committed any offence under the Ordinance or any other serious offence



Not an undischarged bankrupt



Not in liquidation or the subject of a winding-up order



\* The Authority will consider the relevant conviction records of an applicant or any related person for not less than 5 years preceding the date of application.



Hotels and Guesthouses may conduct  
local consultation when necessary

# Enforcement and Prosecution Against Unlicensed Hotels and Guesthouses!

## According to the Ordinance

- ◆ The owners and tenants should ensure that the premises are not to operate as unlicensed hotel or guesthouse.
- ◆ Enforcement officers are empowered to apply for a search warrant to inspect and collect evidence of the unlicensed premises.



# Enforcement and Prosecution Against Unlicensed Hotels and Guesthouses!

## According to the Ordinance

- ◆ The maximum penalty to \$500,000 and imprisonment to 3 years.
- ◆ Issuing a closure order to the premises of repeat offence for 6 months.
